Population-Environment Balance is a national, non-profit membership organization dedicated to maintaining and improving the quality of life in the United States through population stabilization.

Dear BALANCE Supporter:

2013 provides BALANCE a **Unique Opportunity**, and also presents **Serious Challenges**.

But as the ONLY explicitly Environmental National organization which advocates reducing Mass Immigration to protect the Environment, BALANCE is most favorably positioned to successfully meet the Challenges, by **Mobilizing** our Members and others.

Among the Challenges are:

- Burgeoning U.S. Population Growth of approximately 4
 Million/year, 90% of which results from Mass Legal and Illegal Immigration plus the Offspring of Immigrants.
- An Administration which has encouraged an increase in Mass Immigration (In September, 2012, 27.6% more applications for legal residence in the USA were approved than in September, 2011 – Bloomberg).
- That September, 2012/2011 year-over-year increase in legal immigration of nearly 28% – that is a big number, approaching 500,000 additional legal immigrants annually.
- Two-Thirds of all the Jobs created in the past four years in the USA have gone to Legal and Illegal Immigrants (cis.org).
- Through a series of 3 Executive Amnesties of highly questionable constitutionality, the Obama Administration has, de facto, Amnestied most Illegal Aliens in the USA who have no criminal record, thus bypassing Congress. And this Administration authorized nearly 1 Million WORK PERMITS for the working-age children of Illegal Alien Parents!

Perhaps worst of all, Key Leaders in both Parties have publically recommitted themselves to passing a "Comprehensive Immigration Reform" bill **early in 2013**!! These are Washington D.C. code words for allowing dramatically **increased** Mass Legal and Illegal Immigration!

BALANCE is in a unique position to resist these arrogant attempts to continue changing the demographic make-up of the United States because BALANCE is an environmental organization. The fact that many supporters of the Obama Administration also favor Environmental Protection gives BALANCE a Unique Standing. On grounds that those currently in power should find compelling, BALANCE can resist this Administration's push to open the Floodgates to increased Mass Immigration.

And there is yet another reason for hope that we can stop the Open Borders advocates and even get reductions. The Impending (& doubtless ongoing into 2013) Fiscal Cliff is handing us the opportunity we have been seeking to achieve Real Reductions.

Now that the November, 2012 Elections are over, politicians are going to be forced to realistically address the United States' Massive and Increasing Budget Deficits and Debt and Unemployment and to realistically and dramatically cut Costs.

And as BALANCE supporters know the Fiscal, Employment, and Environmental Costs of adding some 4 Million Legal and Illegal Immigrants and their Offspring to the U.S. Population each year (90% of U.S. Population Growth) are Immense!

And NOW, after the Election, formerly Untouchable Issues, such as Reducing Mass Immigration and thus reducing its massive net Fiscal and Environmental Costs will once again be doable.

After all, what is a Member of Congress or the Administration to Do when presented with Questions and Facts Framed like the following:

Why is the U.S. admitting Millions of Immigrant workers when 1 in 3 young veterans are unemployed?

Why Cut Medicare (or Social Security, or Defense, etc..) when we can save \$7 Billion/Year by eliminating Child Tax Credit Refunds to the Parents of Illegal Aliens?

Why tolerate increasing Unemployment Rates and 25 Million Unemployed Americans – due in part to displacement of American workers by mass immigration – when:

- The Overall Wealth of Americans plummeted 40% from 2007 to 2010. The poverty rate is on track to hit a 50 year high. Forty-five million US residents, mostly American citizens, are on Food Stamps.
- Contrary to official government news drops, the Real U.S. Unemployment Rate is 23% (calculated per 1980s methodology by www.Shadowstats.com), and – from January, 2009 to July, 2012 in the USA:
 - Foreign-born employment ROSE by 1.417 million, but

- Native-born employment FELL by 1.418 million (Rubenstein, www.VDare.com, August, 2012).
- Moreover, according to an April, 2012 DHS report, some one Million sixty thousand Immigrants were admitted to Permanent Legal Residency in the USA via Green Cards in 2011, and were thus AUTHORIZED TO WORK!
- In addition hundreds of thousands of (temporary) work-authorized persons are admitted to the USA each year via Visa's categories such as H1b. Many of these stay permanently, legally or not. Many bring families, and additional children born in the United States become automatic US citizens.

The impact of the nearly 4 Million/yr population increase due to mass legal and illegal immigration imposes great Costs on Hospitals, and Schools (which provide de facto free, i.e. Taxpayer Funded, education and medical care to both legal and Illegal Immigrants), other taxpayer funded services, and the environment.

- And BALANCE supporters should emphasize the following point to every Environmentalist Member of Congress, and the Administration – for every Person added to the United States' population, one acre of Precious Farm Land or Wildlife Habitat is converted to Developed Uses. (David Pimentel, Cornell Univ.)
- And also that the Negative Environmental Impacts of the USA's Mass Immigrationgenerated Population Growth continues, still on trend to reach a total of ONE BILLION in 2075. See BALANCE's Chart posted on our website!
- Indeed, Post-1970 Immigrants and their Offspring will outnumber pre-1970
 Immigrants and the Native-born plus their Offspring, by 2050 if current Immigration and Fertility trends continue, a trend which Official Reports fail to mention.
- And, as another Crucial Service to lawmakers and supporters alike, BALANCE provides accurate numbers regarding the environment, employment and the economy too, thus allowing circumvention of Mainstream Media Spin, Misinformation, and News Blackouts.

For example, no government agency reports Real unemployment (23% today) by the method used through 1980, before the numbers became politicized.

Reciting the foregoing highlights the fact that continuing Mass immigration takes Jobs that could be filled by Americans; that Immigration is extremely economically Costly; that it drives Population Growth and is, therefore, an increasing burden on the Environment.

Thus we all need to begin NOW to publicize these Negatives that result from Mass Immigration. We can candidly say THAT THERE IS A SIMPLE SOLUTION – DRAMATICALLY REDUCE LEGAL AND ILLEGAL IMMIGRATION.

Management Groups refuse to seriously push a zero-net Mass Immigration Moratorium, Pushing a Moratorium, along with other good bills is essential to delegitimizing the whole concept of Mass Immigration. Merely advocating reductions in few categories Legitimizes the continuing Mass Immigration Flow.

Indeed, one inside-the-Beltway Management group recently indicated that the Push for Comprehensive Immigration Reform was only about getting Amnesty for Illegals. That is false. The 'Open Borders' Lobby wants to dramatically **increase legal immigration as well**. That is why pushing a zero-net moratorium is so important!
